Understanding Targeted therapies and Immunotherapies for Cancer (UTIC) Course

The UTIC (*You-Tick*) Course, Understanding Targeted Therapies and Immunotherapies for Cancer is a joint collaboration project between ISOPP and BOPA, the British Oncology Pharmacy Association. It will be launched on April 30th, 2024 and will be hosted on both the ISOPP website and the BOPA website and will be free for all ISOPP and BOPA members to access.

The course spans 5 topics incorporating 24 bite sized videos teaching the learner about

- Cancer biology and genetics
- Targeted cancer treatments
- Introduction to immunotherapy
- Immunotherapy with checkpoint inhibitors
- Targeted treatments and immunotherapies for haematological cancers

A e-certificate will be awarded for completion of the entire course.

ISOPP Educational Needs Assessment Survey (2023-2024)

The ISOPP Education Committee will use the findings of this survey to guide development of any future education activities. Based on the responses received initial action that will be taken:

- Basic level education key topics of focus being bone marrow/hematopoietic cell transplant, palliative care and investigational agents.
- Advanced level education will focus on supportive cares for systemic anti-cancer therapy (SACT), undertaking oncology pharmacy research, SACT medication errors and sharing clinical updates on specific types of cancers (for example, pancreatic, lymphoma, myeloma, hepatobiliary).
- A webinar schedule will be set up for 2024 with the aim of monthly webinars with each being no more than 60 minutes in length.
- It is planned that these webinars will be live presentations that can be recorded and watched at a later date.
- Due to the need for increased resourcing and planning, the committee will further discuss the development of additional structured education programs focusing on the leading topics outlined in the survey.
- To increase access, all educational activities covered in this survey will be provided free of charge to ISOPP members and be conducted virtually, where possible.
- The committee will reach out to respondents who volunteered to assist with the development of educational material.
- The committee will also investigate potential collaborations with other relevant organizations/societies.
- ISOPP can explore potential educational grant opportunities to support development of any educational materials required to meet the interest of members as expressed in this survey.

Virtual Journal Club

From July 2023, after 11 years and 108 editions, articles from the Journal of Oncology Pharmacy Practice (JOPP) would no longer be featured in the Virtual Journal Club (VJC). The VJC was an initiative to encourage ISOPP members to read JOPP articles and then answer a series of multiple choice questions through surveys. After completing the questionnaire, members were emailed a personalized certificate. Although not formally accredited continuing medical education (CME) points, participation was equal to one hour of CME activity. However, participation rates have declined over time and the difficult decision to discontinue the service was made.

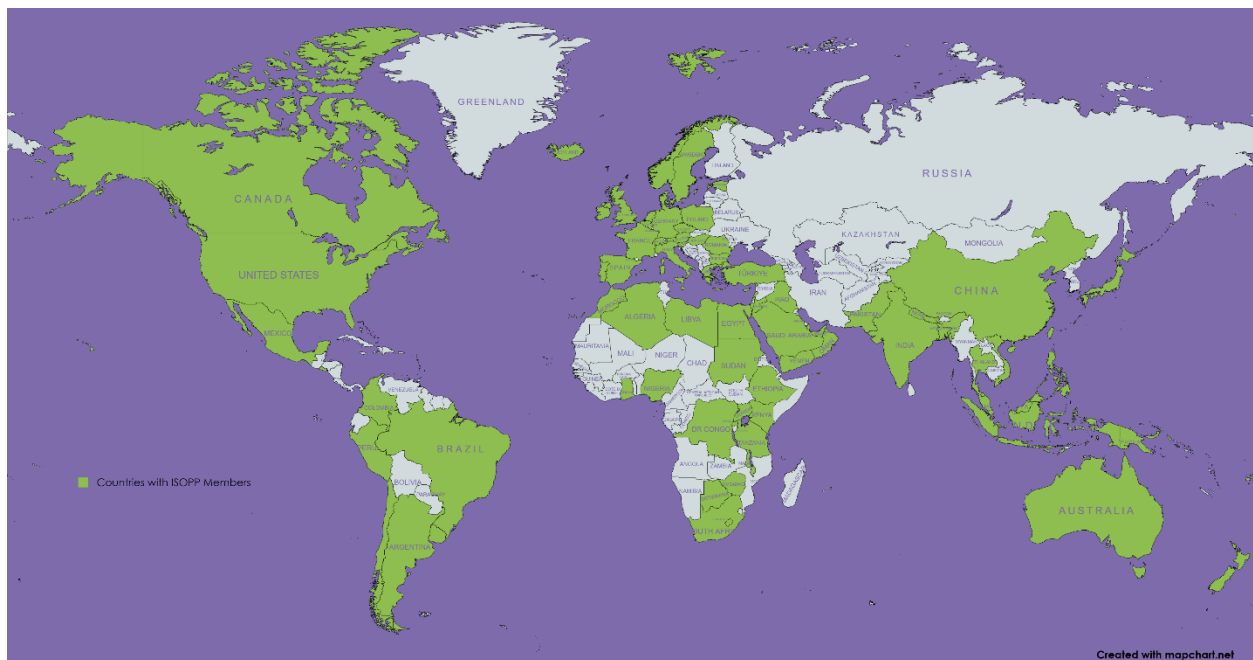
